

Discussion and/or action regarding 2022 Legislative Session

There is no additional funding ask this year <u>per October 2, 2020 Finance Memorandum (Memo No. 20-15) from the Director of Finance</u>. Governor's budget includes SFCA's request to add the following Positions: Deputy Director EM5, and Arts Program Specialist IV SR22 as well as convert Arts Program Specialist III #122671 Position from Temporary (T) to Permanent (P). Trade-off 0.25 MOF N (Federal) Office Assistant to Deputy Director.

Position Funding from operating budget:

- Deputy Director EM5 = MOF B (Special) 75% and MOF N (Federal) 25%
- Arts Program Specialist IV SR22 (Museum Director) = MOF B (Special) 100%

Governor's recommendation to fill three commission posts will be heard this session.

Authorize the Legislative Committee to take a position on legislation - Recommendation: The SFCA Commissioners authorize the Legislative Committee to take a position to either support or not support any bills that impact SFCA. Requested positions to reflect the Strategic Priorities.

Authorize the SFCA Chairperson and Executive Director to testify on Behalf of the Commission - Recommendation: The SFCA Chairperson and Executive Director to testify on behalf of the commission either to support or not support any bills that directly or indirectly impact the SFCA.

Amendments to 103-8.5 HRS - Recommendation: The SFCA oppose amendments to the 1% legislation.
