Exhibition Concept / Description:

The 7th Annual Juried Exhibition at Kahilu Theatre will continue to build upon past versions of the exhibition:

"Kahilu Exhibits at Kahilu Theatre is proud to present *He wa'a he moku. He moku he wa'a.* a group exhibition featuring the artwork of 34 artists with strong ties to Hawai'i. This year's exhibition was juried by Kahilu's gallery director, Andy Behrle, who invited submissions from artists of all media and experience levels. All of the artwork selected was created since March 2020, and represents the vast spectrum of experiences the artists have faced in these trying times."

Artists will receive 70% of proceeds from the sale of their works.

2. Women Artists of Hawaii, Bishop Square Pauahi Tower Lobby, Honolulu, Hi Mixed media, curated.

Exhibition dates: January 7 - March 11, 2023.

#### Exhibition Concept / Description:

This is an inaugural exhibit that we hope will be an annual event. These artists work in variety of media, including oil, acrylic, watercolor, ceramics, silk painting, fiber art, paper making, mixed media sculpture and printmaking. In 1969, D'Angelo moved to Hawaii where she finished her BFA and obtained both an MFA in 1974 and a Masters in American Studies in 1993 from the University of Hawaii. Soon after she embarked on a very successful teaching career at both Honolulu Community College and the University of Hawaii.... Carol D'Angelo was an instructor in the Apparel Product Design and Merchandising Program at the University of Hawaii at Manoa from 1979-2012. She was also the curator of the Historic Costume Collection within the department."

Artists will receive 80% of proceeds from the sale of their works.

3. 2023 Annual Juried Exhibition, Hui No'eau Visual Arts Center, Makawao, HI. Mixed media, juried.

Exhibition dates: January 13 – February 18, 2023.

#### Exhibition Concept / Description:

This prestigious competition gives visitors an opportunity to view current work by local artists in all media. Nationally renowned guest jurors from Maui, Hawai'i and beyond offer a different perspective for a unique show every year. Ceramics, printmaking, sculpture, photography, painting, drawing, jewelry, digital media, fiber, wood, mixed media and all other creative

explorations are welcome. With no theme, this exhibition challenges artists to submit their best work created within the past two years.

Juror: Rosina Potter has worked for more than 15 years in art gallery management, project consulting and community development before being named art director at Four Seasons Resort Maui at Wailea in 2018. As the company's sole arts professional, she managed the Resort's Artists Showcase, a museum-quality permanent collection, and created related programming and activations. She served on the board of Art Maui and consulted on a range of arts and cultural projects in support of local artists. Born in North Carolina, Potter graduated from University of Florida with a bachelor's degree in history and art history. She has lived on Maui since 2004.

Artists will receive 50% of proceeds from the sale of their works.

4. 'Ike Kanaka, Maui Arts & Cultural Center, Kahului, HI. Mixed media, curated. Exhibition dates: January 17 – March 18, 2023.

#### Exhibition Concept / Description:

Maui Arts & Cultural Center, Schaefer International Gallery will present 'Ike Kanaka, co-curated by Gallery Director Neida Bangerter and Assistant Director Jonathan Clark. This invitational exhibition brings together ten Kanaka 'Ōiwi artists to present contemporary work channeled through 'ike: knowledge gained through experience guided by sound teachings. In this way, all 'ike has a mo'okū'auhau, an origin story and chain of succession rooted in ka wā ma mua, or the time gone before, and influencing ka wā ma hope, or the time yet to come. As each artist manifests their 'ike and practice differently, the outcome will collectively inspire and inform. 'Ōlelo Hawai'i will be woven throughout the entirety of the exhibition, providing an important focus that promotes a revitalization of the language of this place. This multi-generational group of artists from nā mokupuni o Hawai'i nei represents a variety of established backgrounds in exhibitions, education, and informed skillsets. The invited artists are: Bernice Akamine, Kala'i Blakemore, Hoaka Delos Reyes, Solomon Enos, Pōhaku Kaho'ohanohano, Lehuauakea, Kawika Lum-Nelmida, Meleanna Aluli Meyer, Auli'i Mitchell, Cory Kamehanaokalā Holt Taum.

Artists will receive 70% of proceeds from the sale of their works.

5. *Celebration of Hawai'i 2023* - "Fire, Earth & Water" - 18th Annual Invitational, Viewpoints Gallery, Makawao, Maui. Mixed media, curated. Exhibition dates: February 4 – March 18, 2023.

#### Exhibition Concept / Description:

Artists from Kaua'i, Oahu, Moloka'i. Lana'i, Maui and the Big Island have been invited to participate in this exhibit based on the high aesthetic quality of their work, its craftsmanship and significance to the theme of reverence to the Hawaiian host culture. Many of them are well-known and have received numerous awards, but it is also an opportunity to show the work of young and promising talented artists. "Reaching Out" projects in line with the theme of "Fire, Earth & Water" have been selected. Events with lectures on those 3 specific Hawaiian topics will be scheduled during the show. Movies recording the process and goal will be shown at

those events. A portion of the gallery profit goes to the participating Hawaiian organizations. For the past three years this exhibit itself has been filmed and recorded on our website at <a href="https://www.viewpointsgallerymaui.com">www.viewpointsgallerymaui.com</a>.

Curator: Joëlle Chicheportiche Perz was born in Paris and was only 16 years old when she moved to the French Alps where she graduated with an honorable mention from the Lycée Honore Romane in Embrun. Falling in love with the Provence District, she chose the Universities of Aix-en Provence and Marseille to study Fine Art and Art History simultaneously. In 1974, a growing interest in mural painting took her to Mexico, starting a journey which allowed her to learn, expand her vision and unleash her creativity as an artist. She studied mural painting at the University of Guadalajara and was soon commissioned by the government to execute a large scale mural in a newly built public school. From 1977-1982, she lived in San Francisco where she studied in depth the techniques of printmaking at the Graphic Arts Workshop. In 1982, she moved to Maui, where she has been living ever since. Hawaii has been a great source of inspiration as well as giving her an opportunity to study with great teachers such as Richard Nelson, Hiroki Morinoue, Sally French and more. Over the years she has herself been teaching in numerous venues over the island, including the Lahaina Art Society, the Hui Noeau visual art center and with the "artists in the schools" art program. As one of the founders of the Viewpoints Gallery and in charge of exhibits for a number of years, she has been able to establish a reputation for prestigious shows such as the Celebration of Hawai'i invitational, the Malama Wao Akua Annual Juried Show and the Hawai'i Contemporary Invitational as well as many significant and educational shows such as the ongoing "Reaching Out" exhibits Artists will receive 50% of proceeds from the sale of their works.

#### My approach to critiquing a work of art:

I believe fine craftsmanship in any media is very important. The artist should be creating a unique work of art, not copying something some other artist has done. I like to see an artist push the boundaries of the media in some way to produce a work that is fresh and exciting. The work that is most interesting is work that has a concept or personal statement.

#### **Experience in Visual Art:**

My parents were both artists (primarily painters) and we had a gallery on the road to the Spouting Horn on Kauai where I grew up. I majored in ceramics and fiber arts at the University of Hawaii. I received a BFA in Ceramics in 1974 and an MFA in Fiber Arts in 1979. I taught Fiber Arts at UH from 1980-1987 then I embraced full time motherhood. From 1998-2005 I worked as a Museum Educator at the Contemporary Museum. I arranged school tours and children's classes and the Art Spree festival. I taught weaving and fiber arts at the Honolulu Museum Art school from 2006-2020. I was a teaching artist for the SFCA Artist in the Schools program as well as the HISAM Art Bento program from about 2006-2022. I also taught after school kids classes at Noelani Elementary from 2006-2020 and summer school art classes at Iolani school from 2004-2016. Over the years I have exhibited in a large number of juried and group shows in Hawaii. A number of my artworks have been purchased by the SFCA. I have not exhibited much outside of Hawaii but I do keep up with the contemporary art scene by visiting museums and galleries where ever I travel and I subscribe to American Craft and Fiber Art Now magazines.

My expertise and personal studio practice is focused on two-dimensional art, specifically all forms of drawing and painting. I also have sufficient knowledge of design principles and three-dimensional art that affords me the ability to critique and evaluate sculptural works in glass, wood, ceramic, and metal.

#### c. Briefly describe your approach in critiquing a work of art.

My approach to critiquing a work of art integrates in-depth observation and analysis of the work's formal qualities with interpretation and evaluation of its meaning. I look at all of the various elements of the artwork—medium, scale, format, line, shape, form, texture, color, space—and then explore the relationship between these elements. Based on the evidence, I formulate as many interpretations of the work as possible. I ask myself, "What is the context of this artwork? Why did the artist make this? What does the artwork mean? How does the artwork mean?" I then evaluate how successfully the artwork weds technical approach and achievement with conceptual strength and fecundity. Important evaluation questions for me are, "How do the formal qualities of the work register or contribute to its conceptual and/or emotional content? How rich and varied are the artwork's possible meanings? How original, dynamic, and contextually relevant is the artwork?"

I received my BA in Studio Art from the University of Arizona in 2005 and my MFA in Drawing and Painting from the University of Hawai'i at Mānoa in 2011. Since 2012, I have served as part-time faculty in the Drawing and Painting Program at UH Mānoa, where I have instructed courses at all levels from introductory to advanced. From 2008-2018 I served as an instructor at the Honolulu Museum of Art School, where I taught youth and adult classes as well as worked for every outreach program offered by the Art School, including Art-to-Go, Wounded Warriors, Artists-in-the-Schools, and the Ambassador Program. I also co-led a number of multi-day workshops for DOE teachers that focused on developing arts-integrated curriculum. From 2015-2020 I worked for the Art Bento Program at the Hawai'i State Art Museum, where I served as both a Museum Guide and a Teaching Artist. 
