

More than ever, we want to express our commitment to honor our extraordinary island and host culture. Viewpoints Gallery is committed to support Maui Artists in a wide range of media expressing their creativity in these difficult times.

A significant donation from this exhibit will go to sustain our efforts to support all the artists that saw their lives impacted by the recent Maui fires. During the summer exhibit we gave 100% of our profit to help Maui artists which exceptionally came to about 20% of our gross income for that show, because so many of our collectors were eager to help.

For the **Emergence** exhibition we estimate that we will give between 10 - 15%, accordingly to where the gallery is at financially, since we want to make sure that we can still operate under the downsizing of our tourism industry on Maui for the months to come.

Emergence invites Maui artists who are usually not part of Viewpoints Gallery, but were living and working in Lahaina or Kula and their homes and/or studios were destroyed. Other Maui artists affected by the tragedy, who lost a huge inventory in Lahaina's galleries and now have lost an important venue to exhibit their work will also be invited. The exhibition will feature Maui artists, with the exception of a few 3D artists, which we will select based on the theme and who are eager to support Maui artists. "Emergence" is different from the gallery's "Celebration of Hawai'i" exhibition, because of the theme and asking the artists to speak and express their emotions and current situation in their creative visual language. We will try to open this venue to as many affected artists as possible, but with the importance to retain the quality of curated exhibits. Curator is Joelle C. Perz, exhibition coordinator and curator for Viewpoints Gallery.



Approve artist Jane DeDecker's increased project scope for Art in Public Places (APP) Commissioned Work of Art at Women's Community Correctional Center: Hookipa Cottage.

FACTS:

After reviewing the artist's mobilization phase, the AAC for the Women's Community Correctional Center Hookipa Cottage Transitional Housing Unit has recommended that artist Jane DeDecker's increased scope should include an increase to the sculpture's size to 125% of human proportion and a 10% contingency for project delays. AAC meeting was held on October 6, 2023 over Zoom to discuss new scale and project's next steps.




Our design is of a female figure seated with outstretched arm draped in Hawaiian lei's that she is offering to her fellow Hawaiians and the island at large; in an expression of aloha; compassion, gratitude and acceptance.

She is a universal figure of compassion and acceptance, representative of a Tutu (grandmother). It is our hope that this figure will provide a positive space for the women, workers and visitors, where one can sit and reflect, seek guidance, see themselves in her, or someone they love.

"Beyond a greeting, aloha can describe a deep love and respect for people—including oneself—and places. The ancient kahunas (priests) taught that living the Spirit of Aloha meant sending and receiving positive energy to everything and everyone in your environment." (PBS, American Masters)

The benevolent gesture of the sculpture is symbolic of the traditional Hawaiian customs of 'Aloha' and 'Ho'okipa', the Native Hawaiian value of hospitality and giving. Native Hawaiians have always believed in selflessly extending themselves to others, whether they had close ties with them or not. This is an ideal sentiment for artwork representing the renovated Ho'okipa Cottage, where women learn ways they can individually grow and contribute to the greater community. The more one cares for the world, the greater the world will sustain and provide.
