This exhibition, "Mai Ka Pouli: (Re)presentations of Moananuiākea" invites artists from Hawai'i and the Pacific to create or share existing works which respond to historic photographs which are currently held in the Los Angeles County Museum of Art's Pacific Island Photograph Collection.

This project which aims to broaden conversations about identity and representation Pacific Islanders which acknowledges the inherent and enduring effects of colonialism, tourism, militarism and the "Western Gaze" on the people and lands of Moananuiākea It is my hope that this exhibition will activate dialogue for us to learn, heal and empower our communities. The collection contains over 9,700 treasures such as postcards, lantern slides, cabinet cards, and thousands of photographs from Hawai'i, Samoa, Aotearoa, Tonga, Fiji, Tahiti, Rapa Nui and beyond, spanning from 1840 to 2016. The collection was recently digitized and access to the collection will be provided to the participating artists.

Approximately 12 - 18 artworks of diverse media will be presented in this exhibition and will include photographs, prints, paintings, digital video, fiber arts and collage.

**Curated exhibition description:**

This two-person exhibition will feature new artwork by Kaua'i-based husband and wife artists, Doug and Sharon Britt. The exhibition will celebrate the duo's creative partnership and exchange over the last forty years. The exhibition is co-curated by Honolulu-based contemporary art curator, Josh Tengan, and veteran Hawai'i-based interior designer, Jamie Jackson. Doug Britt's paintings and sculpture incorporate contemporary icons of Hawaii: planes, ships, tourism – objects that embody the modern-day experience of paradise. Britt's works are riddled with playful and humorous undercurrents, while exploring the implicit contradictions of island life. Sharon Britt has enjoyed a lifelong affinity for fiber and, in particular, woven and coiled basketry. They provide the primary material for her work, in which the dark root hairs are coiled and bound with waxed linen thread, gradually built into totemic figures, and further animated with the addition of shells and strands of kapa.

This exhibition, "Mai Ka Pouli: (Re)presentations of Moananuiākea" invites artists from Hawai'i and the Pacific to create or share existing works which respond to historic photographs which are currently held in the Los Angeles County Museum of Art's Pacific Island Photograph Collection.

This project which aims to broaden conversations about identity and representation Pacific Islanders which acknowledges the inherent and enduring effects of colonialism, tourism, militarism and the "Western Gaze" on the people and lands of Moananuiākea It is my hope that this exhibition will activate dialogue for us to learn, heal and empower our communities. **Curated exhibition description:**

This two-person exhibition will feature new artwork by Kaua'i-based husband and wife artists, Doug and Sharon Britt. The exhibition will celebrate the duo's creative partnership and exchange over the last forty years. The exhibition is co-curated by Honolulu-based contemporary art curator, Josh Tengan, and veteran Hawai'i-based interior designer, Jamie Jackson. Doug Britt's paintings and sculpture incorporate contemporary icons of Hawaii: planes, ships, tourism – objects that embody the modern-day experience of paradise. Britt's works are riddled with playful and humorous undercurrents, while exploring the implicit contradictions of island life. Sharon Britt has enjoyed a lifelong affinity for fiber and, in particular, woven and coiled basketry. They provide the primary material for her work, in which the dark root hairs are coiled and bound with waxed linen thread, gradually built into totemic figures, and further animated with the addition of shells and strands of kapa.
