Wahiawā Civic Center

Architecture Notes from AHL: Wahiawā is a district centrally located on the Island of O`ahu. The name Wahiawā has multiple meanings, one of which is "Place Everlasting". Wahiawā is also home to Kūkaniloko, "one of the two famous places in the Hawaiian Islands for the birth of children of tapu chiefs" (McAllister 1933:134). Kūkaniloko was not only the place where women of royal lineage came to give birth to future chiefs, it was also the grounds where the chiefs trained in warfare and leadership. A visit to this deeply spiritual site gave the design team an understanding of the sense of peace and calm imbued in the meaning of "Place Everlasting".

In addition to its historical significance as a birthplace of chiefs, Wahiawā has strong ties to its military and plantation past. Schofield Barracks occupies a significant portion of land in the district and the military continues to have a significant presence and impact in the community with O'ahu's annual Veteran's Day Parade taking place on California Avenue.

In 1895, lands in the district became homesteads under the Republic of Hawaii and the name California Avenue, is derived from the many non- Hawaiian families from the U.S., particularly California, who were encouraged to move to the Wahiawa Colony Tract between 1898 and 1899. This area became Wahiawā Town, and California Avenue became the main thoroughfare.

Site planning features a central plaza that serves as the main focal point of the site. The plaza is centered around an existing Ohai tree (monkeypod native to India) which symbolizes how different cultures came together over time in Wahiawā. The plaza will have radial paving patterns, low stone walls, and native planting that draws inspiration from Wahiawa's history and local fauna. The central plaza is envisioned as a peaceful contemplative space for the community to relax before they enter either the State or District Court buildings.

STATE FOUNDATION ON CULTURE AND THE ARTS ART IN PUBLIC PLACES PROGRAM STAFF REPORT ON COLLECTIONS MANAGEMENT POLICY: DEACCESSION

The purpose of this report is to review the SFCA's Collections Management policy regarding the deaccession process.

BACKGROUND

Since the establishment of the Art in State Buildings law in 1967, the State Foundation on Culture and the arts has actively collected and displayed contemporary works of art, primarily by Hawaii artists. This collection of artwork consists of permanent works of art created specifically for locations where it is installed, and relocatable works of art which are rotated throughout state buildings fulfilling the "museum without walls" concept.

The purpose of the Art in Public Places collection...

The process of acquiring works of art for the SFCA ensures each work is evaluated by a community committee against a set of criteria before being recommended to the SFCA commission. This process ensures the collection meets the purpose of the Art in Public Places Program. Even gifts offered to the SFCA must be vetted by the same process and criteria of acquisitions.

As of December 31, 2023, the collection stands at 7,000 relocatable works of art, with over 68% on display. This is a significant percentage on display as the institutional standard is to have 2-5% of ones collection on display at any given time. While this statistic is extraordinary, there are works of art in the collection which have not been displayed for decades.

The goal is to better understand the conditions around these works of art, why they have not been installed in state buildings and what options are available to address the situation.

Works of art are brought into the SFCA collection through the DAGS inventory management process which also details the installation/location and disposal process.

The Art in Public Places Programs Collection Management Policy outlines the conditions and process for deaccessioning works of art. (See Attached Chapter 4.3)

Factors impacting the deaccession include:

- Review goals of the Art in Public Places collection
- Process for selecting works to deaccession.
- Process for deaccession to include donation/sale or auction
- Develop and approve criteria for identifying works of art for deaccessioning (beyond those outlined in Chapter 4, CMP)

- Reporting on works of art not displayed in 10 years.
- Evaluating each work of art against the selection criteria and identify reason for not being displayed.
- Recommend works of art to deaccession

Note* Copyrights of works of art remain with the artist and not the State of Hawaii. Per the Visual Artist Rights Act of 1990 the artists retain their rights to prevent use of their name on any work that has been distorted, mutilated, or modified in a way that would be prejudicial to the artist's honor or reputation; and to prevent distortion, mutilation, or modification that would prejudice the artist's honor or reputation.
