



Maui Arts & Cultural Center will present the group exhibition **FOCUS**, featuring seven contemporary Japanese photographers who go by the collective name of "photography?end?". The group consists of Yuji Hamada, Ken Kitano, Miki Nitadori, Yuki Onodera, Naruki Oshima, Risaku Suzuki, and Kazuyoshi Usui. Their respective avenues of work look at the potentiality of photography in a rapidly evolving digital age, considering the materiality of photography and exploring the relationship between conception, theme, and exhibition of work. Curated Exhibition Concept / Description:

Produced over the past 3 years while living in London, these works by Kainoa Gruspe consist of open-ended musings and reflections on inherited value systems and established sources of knowledge. While varied in subject matter and approach to materials, for the artist this group of paintings revolves around a central device device of verticality as related to values.

Different ideas related to values, certainty, and possibility of knowing are explored within individual paintings. The paintings are made with a range of materials on a semi-transparent fabric and some are double-sided, lending themselves physically to the open-endedness of the narratives within the work.

Kainoa Gruspe's practice comes from painting but has been branching out to include different modes of making, including woodworking, sewing and embroidery, and hat making. What he is looking for in his work is a sense of real life, and an exploration of how that has been understood. Gruspe is from Honolulu, Hawaii. He received a BFA from the University of Hawaii in 2017 and an MFA from the Slade School of Art in London in 2022.

STAFF REPORT TO THE BOARD March 20, 2024

Art Advisory Committee (AAC) Artist Recommendations for the State Capitol Pools project.

DAGS Public Works Division is looking for creative solutions to resolve the longstanding issue of maintaining the State Capitol Reflecting Pools and the structural components adjacent to the pools. Conditions surrounding the pools do not condone filling the pools with water in the future yet, the State historic Preservation Division would like to see the "character" of the pools remain. The SFCA successfully addressed a similar issue with the sculpture garden glass pool treatment at the No.1 Capitol District Building.

Project Description: This project proposes to complete improvements to the State Capitol Building outdoor reflecting pools with a "waterless" solution that will emulate the appearance of water. The reflecting pools are shallow rectangular shaped pools approximately 15 inches deep and approximately 39,000 square feet in area each.

The State Capitol Building's symbolic elements are abstraction of the elements they symbolize. For example, the columns symbolize palm trees but are not constructed of palm fiber, and the two chambers symbolize volcanoes but are not volcanoes. Similarly, the proposed pool treatment will symbolize water without literally being water. This proposed mitigation of symbolizing water without using water represents a long-term strategy for assuring that the water symbol will have the enduring architectural permanence of the other symbolic elements. Lastly, the structure of the pool will be preserved, so that the reflecting pools could be restored to hold water again in the future.

Timeline: The State Capitol Pools project will be a multi-phase project with completion by Fall of 2026.

Recommendation: The Hawaii State Capitol Pools Art Advisory Committee met on March 9 and 12, 2024 to review artist and art fabricator proposals and recommend commissioning artists and artisan fabricator ranked in priority for the State Capitol Pools project pending availability of funding.
