HONOLULU—The Hawai'i State Foundation on Culture and the Arts (SFCA) applications for the Artists in the Schools program are open through March 30, 2025. This program provides quality arts experiences for Hawai'i's pre-K through 12 public and charter school students.

# About the Artists in the Schools (AITS) Program

AITS arts residency grants provide engaging, creative, and fun learning experiences based on the Fine Arts standards for all grade levels, through residencies with qualified, trained teaching artists from the Artistic Teaching Partners (ATP) Roster. Many of these teaching artists integrate their art form with other core curriculum areas, such as language arts, math, social studies, and science, meeting both Fine Arts and other core standards.

### **Program Scope**

A residency consists of a minimum of 5 secondary or 8 elementary sessions by the teaching artist with the same core group of students. The learning experiences must support the Fine Arts Standards from the Department of Education Hawai'i Content and Performance Standards III. Teaching artists on the Artistic Teaching Partners Roster bring dance, drama/theatre, literary arts, mime, music, puppetry, and visual arts to the classroom in their arts residency.

#### How to Apply

Applications for Artists in the Schools school years 2025-2026 and 2025-2027 are now open on <a href="HawaiiGoSmart.org">HawaiiGoSmart.org</a>. The deadline to apply is March 30, 2025. Applications are open to State of Hawai'i Department of Education (DOE) public and charter schools. Schools must apply with a teaching artist from the SFCA Artistic Teaching Partners roster.

## About the SFCA

The Hawai'i State Foundation on Culture and the Arts (SFCA) is Hawai'i's state government arts agency. Established in 1965 by the Hawai'i State Legislature, through the vision and effort of Hawai'i leaders, the creation of a state arts agency made Hawai'i eligible to receive federal grants from the National Endowment for the Arts (NEA), newly established on September 29, 1965. The SFCA is administratively attached to the <a href="Department of Accounting and General Services">Department of Accounting and General Services</a> and funded by the State of Hawai'i and the National Endowment for the Arts.

# **About State Arts Agencies**

State arts agencies were created by legislatures and governors to promote the arts and reduce barriers to cultural participation. Every state and U.S. jurisdiction has a designated arts agency, providing grants, services, and leadership that make the arts accessible to everyone. State arts agencies are funded through appropriations from state legislatures. State arts agencies also receive 40% of the federal grant dollars Congress provides to the National Endowment for the Arts.
