## 6.b. Approval of Visitation Schedule for Recommendations Art Acquisition Selection Committees

#### 6.c. Design Phase Approval for Wahiawa Civic Center

Alex Skees presented to the full board the Design Phase for the 2D commissioned work of art at Wahiawa Civic Center by Wooden Wave. Matthew Ortiz of Wooden Wave presented the design to the Art Advisory Committee. They discussed feedback from the concept phase that was incorporated, including higher-contrasted colors and clearer imagery. Konrad Ng made a comment that SFCA derives most of its funding from public funds, and in turn, gives them back to the community by commissioning public artworks. Karen Ewald responded that commissioned works of art reflect the community because the Art Advisory Committees are made up of community members. A motion to approve the Wahiawa Civic Center Design Phase Recommendation was made by Nalani Brun and seconded by Michael Marshall. The motion passed unanimously.

#### 6.d. Supplemental Agreement – State Capitol Pools

Jonathan Johnson explained the SFCA is working with DAGS Public Works division on replacing the State Capitol Pools water with art glass designed by artist Solomon Enos. Johnson explained that Senator Chris Lee included legislative appropriation for interactive art lighting. Mr. Johnson presented a sample of interactive lighting and explained the process of creating glass samples. Mr. Johnson requested the commission Amend the Solomon Enos Contract by up to an additional \$2,400,000 to include State provided, contractor installed "interactive Art lighting" and Amend the Peters Studio LLC Contract by an additional \$76,000 to provide 20 glass panels and consultant services on installation of the pedestal system. A motion to approve of the art lighting and glass panels was made by Janet Sato and seconded by Susan Browne. The motion passed unanimously.
