Call to Order, Roll Call and Reminders, Establish Quorum -- Chair Beverly Lee called the meeting to order at 6:10 p.m. and established quorum. The July and August Meeting Minutes approved. Ian Custino noted for the record that this was take two of our meeting as the first meeting got disrupted by hackers and we had to restart the meeting logging off and logging back in. The three identified individuals were not allowed back into the room.

- II. Executive Director's Report** (Amy Hammond) -- Amy reported that she has been completing her regular duties and tasks including completing the annual inventory report, attending the Procurement IQ trainging course, FY 2026 Budget Execution Policies and Operational Expenditure Plan, also participated in the ASO training refresher course, Pursued locations for O'ahu float building area and coordinated the Lei Draping Pracice dates for 2026.

(To stand and make change). Beverly requests that every Commissioner thinks of a theme and come

back to the October meeting with a theme. She noted that she would like to cancel the November and December meeting.

- c. **Statuary** (Kimo Alama Keaulana) -- Kimo shared a mahalo with Beverly, Clint and Amy and was glad that the statue and surrounding area is on the radar to get the area the area cleaned and refurbished.
